



LIMITED 15 YEAR WARRANTY

FehrMark, Inc. provides a Limited 15 Year Warranty on UnderDeck PVC outdoor ceiling when installed in compliance with UnderDeck printed installation instructions. This warranty extends to the original homeowner (Purchaser), for as long as they own and occupy the residence upon which the outdoor ceiling materials are installed. UnderDeck PVC outdoor ceiling is warranted to be free from defects in workmanship and materials, and will not split, splinter, flake, chalk, rot, deteriorate or suffer structural damage from termites or fungal decay.

FehrMark, Inc. does not warrant against and is not responsible for, and no implied warranty shall be deemed to cover, any product failure, product malfunction, or damages attributable to: improper installation of UnderDeck outdoor ceiling and/or failure to comply with printed installation instructions; use of UnderDeck outdoor ceiling in an application not recommended by FehrMark, Inc. and/or all local building codes; problems resulting from defects in or failure of the supporting structure on which UnderDeck outdoor ceiling is installed; any act of God (such as flooding, hurricane, earthquake, tornado, or other violent casualty); ordinary wear and tear; or improper handling, storage, misuse or neglect of UnderDeck outdoor ceiling.

It is a condition of this warranty that should your UnderDeck outdoor ceiling show defects; you must notify FehrMark, Inc. in writing within 30 days of discovering the claimed defect and prior to beginning any repair or alteration to your deck. The notice must include a detailed description of the claimed defect, with supporting photograph(s), the date of installation of the UnderDeck outdoor ceiling, and proof of purchase. FehrMark, Inc. representatives must be permitted to inspect the claimed defect as a condition of this warranty. After reviewing all information, FehrMark, Inc. will make a determination regarding the validity of the claim. If FehrMark, Inc. determines that the claim is in accordance with the terms of this Limited 15 Year Warranty, FehrMark, Inc. will provide the necessary product materials to repair or replace the defective UnderDeck products. This warranty will not cover and FehrMark, Inc. will not be responsible for costs and expenses incurred for removal of the defective outdoor ceiling, or the installation of the replacement materials. Replacement outdoor ceiling material will be provided that is as close as possible in color to the original installation, but we do not guarantee an exact match.

Under no circumstances will FehrMark, Inc. be liable for special, incidental or consequential damages. Liability with respect to UnderDeck outdoor ceiling shall in no event exceed the cost of replacement product. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation may not apply to you. These warranties give you specific legal rights. You may also have other rights, which vary, from state to state.

All implied warranties with the respect to this product (including merchantability) are limited to 15 years from the date of purchase.

This warranty shall only be applicable in the United States of America and Canada.
